



AGREEMENT FOR PAYROLL SERVICES

Whereas:

- 1. Company shall provide the SIF to GCC Exchange based on the prescribed format of the Labour Regulatory Authority.
- Company shall transfer an amount equivalent to the total salary amount to be disbursed in a month
 along with relevant services charges and only after receiving such amount from the Company, GCC
 Exchange shall be responsible to disburse the salary to employees of the Company within one
 working day.
- 3. GCC Exchange shall not be responsible for delay in Services due to force majeure reasons.
- 4. According to the applicable labour regulatory authority's (LRA's) guidelines, the First Party agrees to disburse the salaries of the employees of the Second Party.
- 5. After receiving the SIF and the equivalent amount charged by the Second Party, the First Party will release the salary to the Second Party's employee's same day or next working day.
- 6. In this clause, the Second Party agrees to pay the charges mentioned (in the agreement) in full and in advance of each disbursement.
- 7. After payment of the card issuance fee stipulated in the agreement, the First Party shall provide all registered employees of the Second Party with GCC Exchange ATM enabled Tankhwa Cards. It is the second party's responsibility to maintain the ATM card after it has been issued.
- 8. GCC Exchange offers its Tankhwa cardholders an SMS notification service. SMS notification service is a very important security measure. The monthly fee for the subscription to SMS notification service for closed loop Tankhwa Cards will be AED 1. SMS Subscription Yes No
- 9. When an employee's card is deactivated due to resignation, termination, or any other reason, the Second Party agrees to provide the First Party with the notice within seven days after it has occurred.
- 10. In order to refund any unpaid salaries to the Second Party, the First Party must follow the LRA's procedures.





- 11. As part of the agreement, the Second Party agrees to raise claims of non-payment of salary with a 10-day deadline following the incident. Thereafter, the First Party will not bear any responsibility for claims.
- 12. If the Second Party provides incorrect information about its employees' personal or card details or salary period / Contributions or pension amount or pension period of its pension employees, the First Party will not be liable for any claims made arising from that. The First Party will only strive to help and cannot guarantee to rectify any incorrect credit resulting from such information on the part of the Second Party.
- 13. Both parties agree not to disclose or share the information and terms of this agreement with any third party without their prior written consent unless required by a government authority.
- 14. Any modifications or amendments to this Agreement must be made in writing by both parties with their mutual consent.
- 15. Under the terms of this agreement, both parties submit to the exclusive jurisdiction of Dubai courts under the Federal Law applicable in the UAE.
- 16. The Emirati employees must be registered for the pension scheme by their employer (whether government or private) within one month of joining. Employer and employee both contribute to the pension fund, which acts as an end-of-service benefit for the employee.
- 17. Freezone areas that are not registered under MOHRE are able to process salary payments via FTS.
- 18. The Second Party must provide copies of the following valid documents to the First Party:
- ✓ License copy with partner details page (all relevant pages).
- ✓ Labor card copy/print out from MOHRE (MOL).
- ✓ Sponsor's and all partners valid Passport copy / Emirates ID.
- ✓ Company Owners / Sponsors Signature & Company Stamp.
- ✓ Passport copy with address page for non-resident Investors (Only applicable for Non-Visa Investors), Confirmation letter on company letterhead.
- ✓ MOA or Share certificate for all free zones.
- ✓ Manager's Emirates ID copy to be collected if he signs on behalf of the Company, (Only applicable if Manager name is mentioned in TL / POA).
- ✓ Employee list / Emirates ID (Softcopy).
